Any other: Clarification of Autonomous Status.

About autonomous status the UGC representative said that autonomy given to an institution is total and not partial. But the university representative said that since university has to give the degree, the students need to be registered in the university and the UGC representative also agreed that the students need to be registered with the university. The Principal was told to get all the students registered in the university at the earliest. The UGC representative also added that in order to attract students to the college the Gold medalists of the qualifying examinations may be given scholarships/ concession in the college.
