Sir/Madam,

This is with reference to the proposal submitted by St. Xavier's College of Education, Digha Ghat P.O. Patna-800 011 (Bihar) affiliated to Aryabhatta Knowledge University, Bihar under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee, the Standing Committee in its meeting held on 20.09.2018 decided to grant autonomous status to St. Xavier's College of Education, Digha Ghat P.O. Patna-800 011 (Bihar) affiliated to Aryabhatta Knowledge University, Bihar for a period of ten years w.e.f. 2018-2019 to 2027-2028.

The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
